1. Aerosafin S.A. de C.V. continues to have the same address:

2. The company currently holds FAR Part 129 operations specifications in effect with the Federal Aviation Administration (FAA). The FAA Dallas International Field Office maintains these records. Aerosafin's authority to engage in transborder passenger charter services remain in full force.
3. U.S./Mexico charters are encompassed by the U.S./Mexico agreement.
4. Operational Control of the company continues to be held by citizens of the applicant's homeland. There have been no changes to Aerosafin's key management positions since their last renewal.
5. Citizenship of owners and percentages owned has not changed since this information was last provided to the Department. Ownership continues to be held by citizens of the applicant's homeland and there have been no changes.

6. Aerosafin S.A. de C.V. possesses the requisite accident liability insurance coverage. It is current and on file with the Federal Aviation Administration. (Maintained by FAA-AFS-260)
7. The applicant's operating authority issued by its government that relates to the U.S. operations it proposes to continue is current. The International license from the DGAC (TAI) is unchanged. A copy of the latest revision to the AOC is attached. See attachment for copy. (Exhibit A)
8. During the past three years the applicant has not had any safety violations, defaulted on any transportation commitments, or been the subject of a bankruptcy proceeding.
9. We are specifically invoking the automatic-extension provisions of the Administrative Procedure Act, 5 USC 558 sub c, as implemented by 14 CFR Part 377, to keep our exemption authority in effect pending final action by the Department of the renewal request.
