It is company policy to collect this information from all passengers. Passengers who do not provide this information will be denied boarding.

The following additional information will be solicited at booking:

A name and telephone number of a contact from each passenger who is a U.S. citizen.

Passengers who do not wish to provide this information will not be denied boarding, nor will they be coerced by Company employees to provide this information.

## **Storage:**

The information collected will be saved in an electronic database. It will be compiled onto one list to be associated with each covered flight segment, prior to departure of that segment, for easy reference and reporting in case of an aviation disaster.

Pursuant to §243.9(d) the information collected shall only be used by the Company for notification of family members or listed contacts following an aviation disaster. It shall not be used for commercial or marketing purposes.

# Prior to boarding:

Passports will be used to determine citizenship. All U.S. Citizens will not be permitted to board unless their full name has been collected and a contact name and number has been solicited

- Inform the Managing Director of Overseas Citizen Services, Bureau of Consular Affairs, U.S. Department of State at their 24-hour contact phone number (202) 647-1512 immediately upon learning of an aviation disaster involving a covered flight segment operated by JuniPogo LLC dba 70 North.
- 2. Ensure the Company transmits a compilation of the passenger manifest information (pursuant to §243.7) no later than three hours after learning of an aviation disaster involving a covered flight segment operated by the Company.
- 3. Ensure the Company, upon request, transmits a compilation of the passenger manifest information to the Director, Transportation Disaster Assistance national Transportation Safety Board.
