

**APPLICATION OF

FOR RENEWAL OF EXEMPTION**

Pursuant to 49 U.S.C. 41301 and the Department's regulations, Jetport Inc. hereby applies for renewal of its exemption from 49 U.S.C. 41301 which authorizes Jetport Inc. to engage in charter foreign air transportation of persons and their accompanying baggage with small aircraft between the United States and Canada and, subject to prior Department approval, between other countries and the United States. The department granted the above authority to Jetport Inc. by notice of Action Taken dated July 30, 2001, confirmed order 96-6-20. Jetport Inc. requests that this authority, which is scheduled to expire on August 27<sup>th</sup>, 2020 be renewed for a period of at least one year.

Jetport Inc. invokes the automatic provisions of the Administrative Procedures Act, 5 U.S.C. 558©, as implemented by 14 C.F.R. Part 377, to maintain its exemption authority in effect pending a final Department determination on this renewal application.

In support of this application, Jetport Inc. states as follows:

1. Jetport Inc. continues to be fit, willing and able to provide the small aircraft passenger charter services for which it requests renewed authority. The relevant circumstances under which Jetport Inc. received its initial grant of exemption authority are unchanged. Jetport Inc. continues to hold that operating certificate issued by the Home Land Authority to operate with the specifications set out in that certificate. Jetport Inc. is owned and controlled by a citizen of Canada and there has not been any change in corporate structure.
2. Charter flights are encompassed by Canada and United States Aviation Agreements.

3. Jetport Inc.'s renewal application is limited in scope and non-controversial. The services Jetport Inc. proposed to operate are substantially identical to those it performed during the past year, i.e. highly personalized transport services to executives and their invitees using small business-type aircraft. Jetport Inc.'s authority to engage in transborder passenger charter services remains in full force and effect, as does its U.S. authority pursuant to its charter services remains in full force and effect, as does its U.S. authority pursuant to its FAA Part 129 Operations Specifications. #J93 F912F

WHEREFORE, Jetport Inc. respectfully requests renewal of its authority to engage in charter foreign air transportation of persons and their accompanying baggage with small aircraft as set forth herein, and such other relief as may be in the public interest.
