Re: Letter of Intent to Financially Support the Resumption of Commercial Air Service between Jamestown, NY (JHW) and Pittsburgh International Airport (PIT) and Baltimore Washington International Airport (BWI) under the U.S. Department of Transportation Essential Air Service Program

Dear Mr. Borrello:

In direct support of Chautauqua County's efforts to secure commercial air service to/from the Chautauqua County Jamestown Airport under a U.S. Department of Transportation Essential Air Service contract, we are entering into this Letter of Intent to furnish in good faith, financial and other support for the resumption of public passenger flights from Jamestown, NY to designated medium hub airports.

It is in the mutual interest of the County, as Airport Sponsor, and Blackstone-NEY Ultrasonics a business entity with significant business and community service interests in the region, to collaborate financially and through shared or loaned use of other resources, to enable, support and promote commercial passenger service between the County's Jamestown Airport and commercial aviation hubs at PIT and BWI.

Both parties recognize the benefits that will accrue to the community at large and to the parochial interests of the parties through the establishment of routine, scheduled passenger air service at Jamestown Airport. We further recognize that the cost and risks of re-establishing commercial air service in a market that has not been well served will require a significant investment of operating equity, promotional support, integration of local transportation and hospitality services to revive public use of commercial air service from the Jamestown Airport. We are willing and able to share in the financial risk of operating the commercial air service under an EAS program contract in part because of the financial savings and other benefits that will accrue to our organization and our customers as a result of locally accessible commercial air service.

In recognition of the financial and other risks and in acknowledgement of the benefits of commercial air service at JHW, Blackstone-NEY Ultrasonics hereby commits to the following financial and other enabling services support for the express purpose of augmenting the EAS contract subsidy for the commercial carrier routes between JHW and PIT / BWI

Annual direct financial support: \$2,500.00 (Two Thousand Five Hundred) dollars per EAS contract year for a period of 2 (Two) years.
