By Notice of Action Taken ("NOAT"), issued June 29, 2018 in the above-referenced Dockets, DOT granted Air Nostrum Lineas Aereas Del Mediterraneo, S.A. ("Air Nostrum") exemption authority and a blanket statement of authorization to display the "UA*" designator code of United Airlines, Inc. ("United") on the intra-European city-pair segments Air Nostrum operates for Scandinavian Airlines System (SAS).¹

Pursuant to condition (b) in Appendix C of the June 29, 2018 NOAT, SAS and Air Nostrum hereby notify the Department that Air Nostrum has ceased displaying the "UA*" designator code of United on any of its flights operated for SAS.
