RENEWAL APPLICATION FOR AN EXEMPTION
FILED BY LONGTAIL AVIATION INTERNATIONAL LIMITED

1) The name and address of the Applicant are as follows:

The Applicant is a "company limited by shares" organized under the laws of Bermuda. (A "company limited by shares" is the Bermuda equivalent of a U.S. C corporation).

3) For the past sixteen years Applicant has been conducting on-demand, passenger charter operations between Bermuda and the United States and Fifth and Seventh Freedom passenger charters subject to prior approval under 14 CFR Part 212. The Applicant anticipates its passenger charter operations to remain substantially the same. The Applicant will not conduct operations in violation of U.S. cabotage rules. The operations that the Applicant conducts are not encompassed by a bilateral Agreement (except that the Applicant understands that Bermuda, an Overseas Territory of the United Kingdom, is covered by the

bilateral agreement between the United Kingdom and the United States of America). Applicant notes that a large number of U.S. carriers conduct similar charter operations under 14 C.F.R. Part 135 between the United States and Bermuda. The government of Bermuda does not prohibit or restrict these operations, although the government of Bermuda now requires U.S. operators to obtain a charter permit prior to conducting flights to Bermuda under 14 C.F.R. Part 135. Thus it is the case that this application is supported by adequate reciprocity.

Applicant seeks an exemption for at least one year under 49 U.S.C. § 40109.

4) The Applicant holds Part 129 Operations Specifications in effect with the U.S. Federal Aviation Administration currently overseen by the Miami International Field Office IFO-57, 2895 SW 145th Avenue, Suite 221, Miami, Florida.

6) The names and citizenship of stockholders and percentages owned are as follows: One hundred percent of Applicant is owned by Longtail Leasing Services Ltd., a Bermuda Company limited by

shares. Longtail Leasing Services Ltd. is owned 95% by Fabian Bello, and 5% by Martin S. Amick. Both are US Citizens.

Applicant does not believe that the change in ownership raises any regulatory issues under the Department's policy that substantial ownership and control of a foreign air carrier such as Longtail Aviation rest with nationals of the homeland, but to the extent necessary, Applicant hereby requests that the previous waiver of this policy continue in effect.¹ The Department states that it "has a long history of granting waivers from our ownership and control standard when grant of the waiver would not be inimical to U.S. aviation policies or interests."²

In this case, there is nothing inimical to U.S. aviation policies because the ownership is comprised of U.S. citizens and the day-to-day management of the company is not changing. Additionally, the USA has positive aviation relations with Bermuda based on comity and reciprocity and, as noted above, a large number of U.S. Part 135 carriers conduct charter flights between the United States and Bermuda.

Applicant's current ownership and control is also consistent with the Bermuda Civil Aviation Authority (BCAA) requirements, which require Bermudian carriers be managed by Bermudian residents. Applicant currently has four key management personnel who are residents of Bermuda.

Continuing the waiver in this case is consistent with the Department's precedent as there is nothing inimical to U.S. interests or aviation policy of a Bermudian carrier owned by U.S. citizens, the Department previously granted Applicant a waiver of this policy, and the BCAA approves the ownership

¹ Applicant initially applied for exemption authorization from the Department when the carrier's ownership was 90% Irish and 10% Bermudian. The Department found:

the carrier is properly licensed and designated by the Government of Bermuda to perform the proposed services, and there is no evidence on the record that would suggest that there is anything in the ownership and control of the carrier that would be inimical to U.S. aviation policy or interests. Under these circumstances, we find it appropriate to waive our homeland ownership and control policy. (Notice of Action Taken, February 18, 2005, DOT-OST-2004-19978).

The above remains true, and Applicant respectfully submits that grant of the waiver of homeland ownership and control remains appropriate.

structure and Applicant continues to meet its homeland requirements.

7) The Applicant has in effect liability insurance which meets or exceeds the Department of Transportation insurance requirements as delineated in 14 C.F.R. Part 205. A copy of OST Form 6411 (which has been completed by the Applicant's insurance broker) is attached to this filing. The original has been filed with the FAA/AFS-260.

8) Applicant conducts Public Transport Operations pursuant to operating authority issued to Applicant by the Bermuda Civil Aviation Authority, which authority is currently in effect in the form of Air Operator Certificate Number BDA/AOC/0104, which was originally issued in December of 2004. This operating authority is currently issued with a non-expiring date. A copy of the current Air Operator Certificate is attached.

9) Applicant has had no safety violations. Applicant has not defaulted on a transportation commitment in the past year.




