APPLICATION OF AIR ITALY, S.p.A. FOR RENEWAL OF AN EXEMPTION

Pursuant to 49 U.S.C. § 40109 and Subpart C of the Department's Rules of Practice Air Italy, S.p.A. ("Air Italy") applies for renewal of its exemption authority to provide foreign scheduled and charter air transportation of persons, property, and mail to the full extent of the open skies air transport agreement currently in place between the United States and the European Union.¹

In support of this renewal application, Air Italy states the following:

- 1. By Notice of Action Taken dated May 11, 2018, the Department issued an exemption from 49 U.S.C. § 41301 to Air Italy, permitting it "to engage in, in its new name of Air Italy, S.p.A., the foreign air transportation previously granted to Meridiana fly by Order 2012-9-12".² This exemption includes authority to provide:
 - Foreign scheduled and charter air transportation of persons, property, and mail from any point or points behind any Member State of the European Union via any point or points in any Member State and via intermediate points to any point or points in the United States and beyond;
 - Foreign scheduled and charter air transportation of persons, property, and mail between any point or points in the United States and any point or points in any member of the European Common Aviation Area; and

• Foreign scheduled and charter cargo air transportation between any point or points in the United States and any other point or points.³

2. Although Air Italy has suspended its operations to the United States, the carrier

continues to hold a homeland license to provide the service authorized by this exemption.

3. Renewal of the existing exemption held by Air Italy would be in the public

interest, as it would preserve the status quo as the carrier reviews its options.

4. The operations covered by this requested renewal are consistent with the rights

granted to EU air carriers under the U.S.-EU Open Skies Agreement.4

5. Air Italy will continue to comply with all of the conditions and limitations the

Department has attached to their existing exemptions.

6. This Application is timely filed. Air Italy hereby invokes the automatic extension

provisions of the Administrative Procedure Act, 5 U.S.C. § 558(c), as implemented by Part 377

of the Department's procedural regulations.

WHEREFORE, on the basis of the foregoing, Air Italy requests that the Department

grant its request for renewal of exemption authority, and further requests any further relief that

the Department determines to be consistent with the public interest.
