FOR RENEWAL OF EXEMPTION AUTHORITY**

Pursuant to 49 U.S.C. §40109(c), Cherokee Air, Ltd. ("Cherokee Air" or "Applicant"), a flag-carrier of the Commonwealth of the Bahamas, respectfully requests renewal of its Exemption from the provisions of 49 U.S.C. § 41301 to the extent necessary to permit it to engage in charter foreign air transportation of persons, property, and mail between a point or points in the Bahamas and a point or points in Florida, and other charters subject to Part 212 of the Department's Economic Regulations, using small aircraft as defined in 14 C.F.R. §298.2.

In support of this application, Applicant states as follows:


1. By Notice of Action Taken ("NOAT") dated April 29, 2019, the Department granted Cherokee Air renewal of its exemption authority for a period of one (1) year, and will, therefore,

expire by its own terms on April 29, 2020.<sup>1</sup> Cherokee Air requests that its authority to conduct combination charter service be extended by a year.

2. Cherokee Air remains fit, willing, and able to provide charter foreign air transportation to and from the United States.

WHEREFORE, Cherokee Air, Ltd. respectfully requests that the Department of Transportation expeditiously grant the Exemption described herein and such other relief as may be necessary or appropriate.


