APPLICATION OF UNITED PARCEL SERVICE CO. FOR RENEWAL OF EXEMPTION

Pursuant to 49 U.S.C. § 40109 and Subpart C of the Department's Rules of Practice, United Parcel Service Co. ("UPS") hereby applies for renewal of its exemption authority to provide scheduled foreign air transportation of property and mail between the United States and Ecuador, to the fullest extent permitted by the United States-Ecuador Air Transport Agreement ("U.S.-Ecuador Agreement").1

In support of this Application, UPS submits the following:

1. By Notice of Action Taken dated February 22, 2019, the Department granted UPS an exemption under 49 U.S.C. § 40109 which permits UPS to provide "[s]cheduled foreign air transportation of property and mail (1) from points in the United

States, via intermediate points, to a point or points in Ecuador and beyond; and (2) from Ecuador to any point or points."² This authority is set to expire on February 22, 2021.

- 2. UPS currently provides the service authorized by its exemption and has done so since the Department initially granted the exemption.³ The same factors which warranted the grant of the original exemption remain applicable and warrant the grant of this renewal. UPS holds various certificates of public convenience and necessity issued by the Department authorizing UPS to engage in domestic and foreign all-cargo air transportation.⁴ As such, DOT has determined on numerous occasions that UPS is fit, willing and able to provide the proposed service and to conform to the provisions of the Federal Aviation Act and the rules, regulations and requirements of the Department thereunder.
- 3. The authority remains consistent with the underlying U.S.-Ecuador Agreement.⁵
- 4. UPS requests that the exemption authority continue for two years from the Department's final grant of the renewed authority requested herein, or as the Department otherwise determines to be appropriate.
- 5. In accordance with Section 377.10(c) of the Department's rules, this renewal application is timely filed more than 60 days prior to the expiration date of the authority at issue. UPS intends to rely upon the Administrative Procedure Act, specifically, 5 U.S.C. 558(c), which provides that UPS's existing exemption shall not expire until the
