Dear Mr. Kruger:

By Notices of Action Taken in the above-referenced dockets,¹ the Department granted broad statements of authorization and exemptions authorizing codeshare services between United² and its foreign code-share partners, as well as United codeshared flights operated by foreign carriers on behalf of Lufthansa, or Brussels Airlines, or Eurowings.

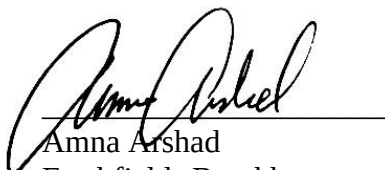
Consistent with Department requirements, United by this letter notifies the Department that, effective immediately, the commercial arrangements for these operations have been terminated and United has ceased placing its *UA designator code on flights operated by the following foreign carriers on behalf of United's blanket codeshare foreign partners: (1) Air Nostrum, Privat Air and

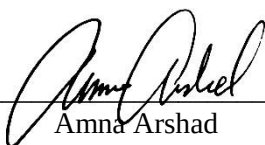
