

NOTICE OF WITHDRAWAL OF APPLICATIONS FOR AN EXEMPTION,
CERTIFICATE, AND FREQUENCIES FOR U.S.-CHINA SERVICE**

On February 26, 2019, Eastern Airlines, LLC (Eastern) applied for an exemption, a certificate of public convenience and necessity, and an allocation of U.S.-China frequencies pursuant to 49 U.S.C. §§ 40109, 41102, 41108 and Subparts B and C of the Department’s Rules of Practice.¹ Eastern specifically requested two U.S.-China Zone 2 frequencies to operate from John F. Kennedy International Airport (JFK) to Ted Stevens Anchorage International Airport (ANC) and continuing on to Jinan Yaoqiang International Airport (TNA).

Eastern concurrently filed a request to reactivate its certificate for interstate scheduled service to enable it to operate the JFK-ANC-TNA service. Due to changes in its operating plans, coupled with the current operating environment with China, Eastern hereby gives notice of withdrawal of its application in this docket.
