Swift Air, LLC ("Swift") submits this notice to inform the Department of developments in the U.S.-Cuba market. Like all air transportation markets, the United States-Havana route has seen material reductions in demand as a result of the COVID-19 crisis. In addition, Swift has been informed that the Instituto de Aeronautica Civil de Cuba has issued an order prohibiting Cuban nationals from traveling to the United States even if they have legal U.S. residence. As a result, Swift and its CSP customers are suspending all U.S.-Cuba flights as of Friday, March 27. Swift and all of its customers intend to resume all approved flights as soon as conditions allow.
