Re: U.S.-Havana Charter Allocation CANCELLATION #2
Docket OST-2020-0011 (2020-2021 Charter Year)

Dear Mr. Kruger:

Pursuant to Order 2020-5-7, Caribbean Sun Airlines, Inc. d/b/a World Atlantic Airlines ("WAA") respectfully notifies the Department that it will not operate U.S.-Havana charters for Havana Air during the period August 16-31, 2020.

WAA holds allocations issued by Order 2020-5-7 to operate charters for Havana Air during the 2020-2021 charter year; these flights are filed as public charter prospectus PC-20-060. To address Cuba's continuing suspension of U.S.-Havana charters due to the COVID-19 pandemic, on July 21 Havana Air advised the Department's public charter office that it was cancelling Cuba flights under this prospectus for the period August 1-14. WAA, in turn, notified your office and the docket on July 22 in WAA's Interim Cancellation #1 that it would not operate twelve (12) charters affected by the July 21 cancellation.

In Cancellation #1 WAA took the position that because of Havana Air's continuing relationship with WAA, those allocations could be used later by WAA and Havana Air without being first returned to the charter pool. Swift d/b/a iAero objected by letter dated July 23, criticizing WAA's good faith argument while admitting that iAero had had its own doubts about this issue and had sought informal DOT guidance (which had not been revealed to WAA at the time of Cancellation #1). While WAA reserves the right to re-assert its Cancellation #1 position if future DOT guidance supports it, WAA will now return allocations

affected by the continued U.S.-Cuba flight suspension, in line with the DOT guidance helpfully submitted by iAero on July 23.

Thus, by this Cancellation #2 WAA is returning fourteen (14) allocations to the charter pool because Havana Air, by e-mail dated August 6, notified the public charter office that 14 flights scheduled through August 31, 2020 with WAA have been cancelled.
