**APPLICATION FOR ALLOCATION FROM U.S.-HAVANA CHARTER POOL  
OF ALLEGiant AIR, LLC**

Allegiant Air, LLC ("Allegiant") hereby applies for an allocation of 125 round trip charter flights from the 2020/21 U.S.-Cuba charter pool established in Order 2020-5-7.<sup>1</sup> Such flights will be operated on behalf of charter operator Anmart Superior Travel LLC d/b/a Anmart Air ("Anmart"). In response to the Order, Allegiant respectfully submits the following information:

1. Currently, Allegiant is authorized to operate 80 FLL-HAV charters and has filed its intention to operate from October 5, 2020 through May 31, 2021. If awarded the 125 flights it seeks, Allegiant would operate the schedule of 205 flights as depicted below:



2. The flights will operate between Ft. Lauderdale, FL and Havana.
3. A copy of the charter agreement between Allegiant and Anmart was previously submitted under separate cover subject to a request for confidential treatment under Rule 12 of the Department's procedural regulations (14 C.F.R. § 302.12). There are no changes to the agreement.
4. This Application will be served on interested parties appearing on the service list.

WHEREFORE, Allegiant respectfully requests that the Department award it 205 round trip charter flights from the 2020-21 charter pool established in the Order.
