Pursuant to DOT Order 2020-4-2, JetBlue Airways Corporation (JetBlue) hereby submits its first monthly air service certification under the CARES Act for the applicable days of April 2020. On April 23, 2020, JetBlue received its funds pursuant to the Payroll Support Agreement with the Department of the Treasury. During the final week of April, JetBlue was in the process of rebuilding its schedule after having previously ceased service in many markets due to COVID-19. In compliance with Ordering Paragraph # 5 of DOT Order 2020-4-2, JetBlue resumed its full service obligations by May 4, 2020, including its winter seasonal service obligations, which JetBlue selected as required by DOT Order 2020-4-2.

Attached is a letter from Steamboat Ski & Resort Corporation stating that direct financial support to JetBlue ceased effective March 22, 2020. JetBlue hereby relies on DOT Order 2020-4-2's industry-wide exemption for communities such as Steamboat Springs, Colorado (HDN), where "direct financial support arrangements between communities and airlines have ceased."
