# RESPONSE OF UNITED AIRLINES, INC. TO REQUEST FOR EVIDENTIARY SUPPORT

United Airlines, Inc. ("United") submits the following in response to the Department of Transportation's (the "Department") request on July 10, 2020 for evidentiary support for the statement contained in paragraph 13 of United's answer that "as a result of its recent change in guidance United has provide[d] the Complainant a refund." United processed a refund for the ticket 0162470654790 on June 11, 2020, and sent notification via electronic mail to Complainant on June 11, 2020. Because Complainant used an Electronic Travel Certificate ("ETC") to pay for a portion of ticket 0162470654790, the refund for that ticket consisted of a reissuance of an ETC for the portion of the ticket was purchased with an ETC, and the remaining balance was credited to the credit card used to purchase the ticket. United processed the refund for ticket 016247065791 on June 11, 2020, and sent notification to Complainant via electronic mail on
