**ANSWER OF SUN COUNTRY AIRLINES**

Sun Country, Inc. dba Sun Country Airlines ("Sun Country") hereby files this preliminary answer in objection to the Joint Application.

The Air Line Pilots Association – International ("ALPA") filed a motion on July 16, 2020, requesting that interested parties have access to confidential documents in this proceeding and that the Department suspend the procedural dates until ten days after the Department has issued a notice granting access to the confidential information and the Joint Applicants have provided affidavit holders with actual access to the documents. Sun Country and the Joint Applicants themselves filed answers in support of the ALPA motion on July 20 and July 21, 2020, respectively. The Department has not yet acted on the motion.

Consequently, Sun Country is filing this preliminary answer to advise the Department that it will provide a substantive response to the Joint Application on the date set by the Department in the Order or Notice responding to ALPA's motion.
