APPLICATION OF AZUR AIR, L.L.C. FOR A FOREIGN AIR CARRIER PERMIT AND EXEMPTION

Azur Air L.L.C. ("Azur"), an air carrier of the Russian Federation, hereby applies, pursuant to 49 U.S.C. §§ 41301 and 40109, Part 211 of the Department's Economic Regulations (14 C.F.R. Part 211), Subparts B and C of the Department's Rules of Practice in Proceedings (14 C.F.R. §§ 302.201 and 302.301, et. seq.), and the Department's streamlined licensing procedures, for a foreign air carrier permit and an exemption authorizing the carrier to engage in scheduled foreign air transportation of passengers and cargo between a point or points in the Russian Federation, via intermediate points, to Miami, and beyond to third-country points to the extent permitted under the U.S.-Russian Federation Air Transport Agreement, as amended, as well as foreign air transportation of passengers and cargo on a charter basis to the extent provided in the bilateral.

In support of its Application, Azur submits the following information:

- Azur is a private limited liability company organized under the laws of the Russian Federation. Its principal place of business is Vzletnaya Street, Building 57, Office 29, City of Krasnoyarsk, Krasnoyarsk Region, Russian Federation, 660135.
- 2. The Federal Agency for Air Transport (Rosaviatsiya) of Russia is the air transport authority with regulatory jurisdiction over Azur. The address of the agency is Leningradskiy prospect, 37/2, Moscow, Russian Federation, 125993. The relevant contact person at the agency is Mr. Alexander Neradko.
- 3. Azur requests expedited approval of this application in order to implement its plans to commence service to the United States. Since the carrier plans to operate only two flights per week carrying passengers and cargo, the request is modest. The flights are limited to operations to and from Miami on the carrier's B767-300 and B777-300 aircraft. The carrier plans to commence operations in December 2020.
- 4. Azur's management is highly experienced in passenger and cargo air transportation, and Azur operates as the seventh largest Russian air carrier in terms of passenger traffic. Azur began operations in 2015, taking over operations of Katekavia Limited, a Russian regional air carrier established in 1994. A list of the names, titles, addresses, and citizenship of Azur's key management personnel is attached hereto as Exhibit A. All of the personnel listed as corporate officers in Exhibit A are citizens and residents of the Russian Federation. One of the three supervisory board members is of Turkish

- citizenship. To the best of the Applicant's knowledge and belief, none of these persons are related by blood or marriage, with the exception of Natalya Viktorovna Koçkar, member of the Supervisory Board, who is the daughter-in-law of the chairman of the Supervisory Board.
- 5. One hundred percent of the stock of the carrier is owned by ONE2FLY, a Russian limited liability company. The shareholders of ONE2FLY are Anna Viktorovna Fukalova (General Director with 55% of shares), a citizen of the Russian Federation and Natalya Viktorovna Koçkar (a participant with 45% of shares), a citizen of the Russian Federation. A statement to that effect is attached hereto as Exhibit B.
- 6. Azur does not hold any direct or indirect interest in any U.S. or foreign air carriers, nor does it have any interest in persons engaged in the business of aeronautics, or any common carrier, within the meaning of the Department's economic regulations, or any person whose principal business is the holding of stock in, or control of, any air carrier.
- 7. Azur is privately owned. It is neither wholly owned nor substantially controlled by the Russian government. Azur has received financial aid from the Russian government as a result of the Covid-19 pandemic-related downturn, and expects to receive approximately \$2MM more in the next two months. This is part of a grant program in response to Covid-19 and does not reflect any extension of ownership or control to the Russian Federation. The Russian Federation does not hold any equity interest in the carrier, nor does it have responsibility for managerial decisions.

- Azur's insurance meets the requirements set forth in 14 C.F.R. Part 205.
 Copies of the carrier's Certificates of Insurance (OST Forms 6411) are attached hereto as Exhibit C, and the originals will be filed with the Federal Aviation Administration.
- 9. Azur has been licensed by the Russian Federal Agency for Air Transport to provide the services described herein. A copy of the carrier's Operating Certificate is attached as Exhibit D. This authority, which was originally granted in November 2017, remains in force until revoked or suspended.
- 10. Azur is a charter and scheduled passenger airline with over five years of experience. Azur has extensive experience in transporting tour groups and regular passengers to popular destinations in Europe, Africa, the Middle East and Far East, Southeast Asia and the Caribbean. Azur has operated both within Russia and internationally during the past five years. Azur succeeded Katekavia Limited, a former subsidiary of Utair Group, and operated under the Katekavia air operator certificate from 2015 until 2017, when Azur was licensed in its own name. An operating history of the carrier is attached as Exhibit E.
- 11. Azur currently operates a fleet of 30 all-Boeing aircraft, ranging from Boeing 737-800's to Boeing 777-300's; most of these aircraft are registered in Bermuda. A list of the aircraft that will be available to perform services to the United States is attached hereto as Exhibit F. Only B767-300 and B777-300 aircraft models will be operated under this permit, if approved. Other aircraft will be used to support Azur's operations outside of the United States, in accordance with the services described in Azur's Operating History, Exhibit E. No aircraft are wet-leased.

- 12. Azur's aircraft are maintained at the carrier's maintenance base at Vnukovo Airport (VKO), Russia, in accordance with procedures recommended by the aircraft manufacturer, Boeing, and approved by the State of Registry of the aircraft. These procedures and standards comply with the provisions of Annexes 1, 6 (Part 1) and 7 of the International Civil Aviation Organization. In addition, Azur plans to enter into a maintenance contract with a local maintenance and repair organization approved by the Bermuda CAA (as the State of Registry). The Russian Federation and the United Kingdom are ICAO member states.
- 13. There are currently no cooperative arrangements or any other agreements in effect between Azur and any U.S. or foreign air carriers that would affect the services covered by in this application.
- 14. Azur has the financial resources to successfully operate the proposed services. The required financial summaries for Azur, shown in US Dollars, are attached hereto as Exhibit G. These statements demonstrate that the Company is in sound financial shape, with a healthy balance sheet, and a small loss for 2019 owing to the carrier's significant growth. (The financial information provided herein is being filed confidentially under seal, pursuant to 14 C.F.R. § 302.12).
- 15. Azur receives limited financial assistance from its home government. Azur expects to receive approximately \$2MM in the next two months from the Russian government. As described above, this is a grant that responds to Covid-19 and is not conditioned on government ownership or participation in the business.
- 16. Forecasted traffic and financial results for the first full year of the proposed operations are attached hereto as Exhibit H. (Pursuant to 14 C.F.R. § 302.12,

Azur requests confidential treatment for this information.)

- 17. The services proposed by Azur are consistent with the 1994 Air Transport

 Agreement Between the Government of the United States and the Government

 of the Russian Federation, as amended most recently by the February 2013

 protocol. The U.S.-Russia Air Transport Agreement grants limited rights to both

 U.S. and Russian designated air carriers. The proposed services are consistent

 with the rights provided in the agreement. Azur Air has been designated by its

 government under the bilateral for scheduled Moscow-Miami passenger/

 combination service up to five times per week. (See Exhibit I, attached.)
- 18. The Russian Federation admits U.S. carriers' applications for scheduled and charter authority consistent with the Air Transport Agreement.
- 19. Azur has not experienced any safety or tariff violations in the past five years nor has it been involved in any fatal accidents during that time.
- 20. Azur has executed a Warsaw Convention Liability Waiver (OST Form 4523), which is attached hereto as Exhibit J.
- 21. Azur will prepare and file in the appropriate dockets, and this docket, a

 Passenger Manifest Information Plan under 14 CFR Part 243 and a Family

 Assistance Plan under 49 U.S.C. § 41313(c).
- 22. The operations proposed by Azur will not result in a near term increase in fuel consumption of ten million gallons or more. Consequently, grant of the authority requested herein will not constitute a "major regulatory action" under the Energy Policy and Conservation Act of 1975, as defined in 14 CFR § 313.4(a)(1).
- 23. Azur is fit, willing and able to perform the services for which the authority

requested herein is sought. Moreover, Azur will comply with the Department's rules, regulations and applicable statutes, and will accept and comply with the Department's standard terms and conditions imposed on foreign air carrier

exemptions and foreign air carrier permits for scheduled and charter air services.

24. The verification required by 14 C.F.R. 302.4(b) is attached hereto as Exhibit K.

WHEREFORE, based upon the foregoing information, Azur Air respectfully requests that the Department approve this application and issue an exemption and a foreign air carrier permit authorizing the scheduled and charter air transportation of persons, property and mail as more fully described herein. Azur Air further requests that the Department grant such other or additional relief as it considers consistent with this Application and the public interest.

AZUR AIR OPERATING HISTORY

Based at Moscow's Vnukovo International Airport, Azur Air has become one of the largest charter airlines in the Russian Federation, and as of 2019, the seventh largest Russian air carrier in terms of passenger traffic. The carrier initially operated under the name Katekavia Limited Air, as a legal successor to that company, a regional carrier dating back to 1994. The following year it was established as a separate legal entity, Azur Air LLC. The Air Operator Certificate was issued to Azur Air in 2017.

Azur Air's fleet consisted initially of four Boeing 757-200 aircraft; the fleet grew to 14 aircraft by 2016, consisting of nine B757's and five B767-300's. The fleet has grown steadily in the intervening years, commensurate with the carrier's expanded operations, and now consists of 30 aircraft, from B737-800's to B777-300's.

Passenger traffic has grown tremendously during the carrier's brief history, from 2.35 million passengers (9.113 billion RPK's) to 5.79 million passengers (24.447 billion RPK's) in 2019. Its average load factors during this period have ranged from a low of 93.7% to 95.9%. Azur Air's on-time performance has been equally impressive; measured by delays of no more than two hours, its performance during the summer of 2019 was 98%.

In 2019, Azur Air operated 11,220 round-trip flights, most of them from its Vnukovo base. Destinations include over 40 points in the Russian Federation and over 30 points in the Mediterranean, the Middle East, Southeast Asia and North Africa, as well as Mexico, Cuba and the Caribbean. The carrier now accounts for about 40% of the total passenger traffic carried at Vnukovo.

AGREEMENT

The undersigned carriers (hereinafter referred to as "the Carriers") hereby agree as follows:

1. Each of the Carriers shall, effective May 16, 1966, include the following in its conditions of carriage, including tariffs embodying conditions of carriage filed by it with any government:

"The Carrier shall avail itself of the limitation of liability provided in the Convention for the Unification of Certain Rules Relating to International Carriage by Air signed at Warsaw October 12th, 1929, or provided in the said Convention as amended by the Protocol signed at The Hague September 28th, 1955. However, in accordance with Article 22(1) of said Convention, or said Convention as amended by said Protocol, the Carrier agrees that, as to all international transportation by the Carrier as defined in the said Convention or said Convention as amended by said Protocol, which, according to the contract of Carriage, includes a point in the United States of America as a point of origin, point of destination, or agreed stopping place

- (1) The limit of liability for each passenger for death, wounding, or other bodily injury shall be the sum of US \$75,000 inclusive of legal fees and costs, except that, in case of a claim brought in a State where provision is made for separate award of legal fees and costs, the limit shall be the sum of US \$58,000 exclusive of legal fees and costs.
- (2) The Carrier shall not, with respect to any claim arising out of the death, wounding, or other bodily injury of a passenger, avail itself of any defense under Article 20(1) of said Convention or said Convention as amended by said Protocol.

Nothing herein shall be deemed to affect the rights and liabilities of the Carrier with regard to any claim brought by, on behalf of, or in respect of any person who has willfully caused damage which resulted in death, wounding, or other bodily injury of a passenger."

2. Each Carrier shall, at the time of delivery of the ticket, furnish to each passenger whose transportation is governed by the Convention, or the Convention as amended by the Hague Protocol, and by the special contract described in paragraph 1, the following notice, which shall be printed in type at least as large as 10 point modern type and in ink contrasting with the stock on (i) each ticket; (ii) a piece of paper either placed in the ticket envelope with the ticket or attached to the ticket; or (iii) on the ticket envelope:

"ADVICE TO INTERNATIONAL PASSENGER ON LIMITATION OF LIABILITY

Passengers on a journey involving an ultimate destination or a stop in a country other than the country of origin are advised that the provisions of a treaty known as the Warsaw Convention may be applicable to the entire journey, including any portion entirely within the country of origin or destination. For such passengers on a journey to, from, or with an agreed stopping place in the United States of America, the Convention and special contracts of carriage embodied in applicable tariffs provide that the liability of [certain]*

[(name of carrier) and certain other] carriers parties to such special contracts for death of or personal injury to passengers is limited in most cases to proven damages not to exceed US \$75,000 per passenger, and that this liability up to such limit shall not depend on negligence on the part of the carrier. For such passengers traveling by a carrier not a party to such special contracts or on a journey not to, from, or having an agreed stopping place in the United States of America, liability of the carrier for death or personal injury to passengers is limited in most cases to approximately US \$10,000 or US \$20,000.

The names of Carriers parties to such special contracts are available at all ticket offices of such carriers and may be examined on request.

Additional protection can usually be obtained by purchasing insurance from a private company. Such insurance is not affected by any limitation of the carrier's liability under the Warsaw Convention or such special contracts of carriage. For further information please consult your airline or insurance company representative."

- 3. [This Agreement was filed with the Civil Aeronautics Board of the United States. The Board approved it by Order E-23680, adopted May 13, 1966. The Agreement (Agreement 18900) became effective May 16, 1966. On January 1, 1985, this Agreement became the responsibility of the Department of Transportation (DOT) by operation of law.]
- 4. This Agreement may be signed in any number of counterparts, all of which shall constitute one Agreement. Any Carrier may become a party to this Agreement by signing a counterpart hereof and depositing it with DOT.
