Letter of Intent for Exemption No. 18512B

Dear Inspector Sullivan:

Corvus Airlines, Inc. dba Ravn Alaska is a Part 119 certificate holder (7C7A855N) that intends to utilize the provisions of Exemption No. 18512B. Once authorized through Ops Spec A005, the exemption will be utilized in accordance with the following tables for our Approved Flight Operations Training Program (FOTP). Corvus Airlines, Inc. will comply with the conditions and limitations as set forth in the exemption.

Due to the COVID-19 pandemic, performing required emergency drills to include donning of oxygen masks, PBEs, performing CPR drills, and donning training life vests increases the possibility of COVID-19 transmission. This exemption allows crewmembers completing the recurrent and/or upgrade training, checking, and evaluation events listed below to perform the listed required tasks with an Alternate Method of compliance.

The following table identifies the Alternate Methods of compliance for each specific training/checking/evaluation events required for crewmembers during recurrent and upgrade events. Only the listed alternate methods of compliance may be used in order to satisfy the requirement.

Other Restrictions with Corvus Airlines' use of this exemption:

- This relief applies to the requirements for recurrent training for crewmembers and to pilots completing pilot in command upgrade training who were previously qualified on the same airplane type as second in command.
- The relief does not apply to requirements for the training and qualification of new personnel and/or initial flight attendant training.
- Any crewmember that performs emergency drills or performance drills utilizing the alternate method above must complete the drills using the normal procedures during the person's next regularly scheduled recurrent ground training or within 12 calendar months (plus grace month) of the event in which the use of these alternative methods was utilized, whichever is earlier.
- This exemption allows alternate methods of compliance only for subsequent operations in the United States.

Use of this exemption will be terminated on November 30, 2020 unless sooner superseded or rescinded, or otherwise extended. I have attached a Safety Risk Assessment to this letter to manage the risk associated with the change.
