(Docket No. FAA-2021-0987). This information is necessary for the Federal Aviation Administration (FAA) to process your petition.

- 1. In your petition, you state in Section I. Summary: "The language in this petition is written to allow THE COMPANY flexibility to operate both the AG122, and AG116, as well as other similar Hylio Inc. aircraft models with a takeoff weight under 140 pounds."
