RE: Export of Maned Wolf to Altina Wildlife Park in Australia.

Part G: Justification for Requested Activity.

7. Provide a full statement justifying the proposed activity.

a) Altina Wildlife Park is part of an Accredited ZAA group of institutions striving for the conservation of many species which includes Maned Wolves. Maned Wolves in Australia were in dire straits as all animals left were all related. Altina decided to take the whole group into its own establishment in November 2008 and proceeded to import individuals. The first imported animal arrived from Riga Zoo in Latvia and this is when we began our breeding program. A second individual was then imported from Sweden and thus began the revitalisation of the species in Australia. We started off with 7 related and mostly aged animals and have brought genetic viable individuals and numbers to where we now have 22 with more births pending. Because of our success other Australasian Zoos are now interested in taking on our plight to keep this species viable and we have currently sent 5 animals to other zoos in Australia with 4 more zoos wanting to acquire.

To keep this species viable we need to infuse new bloodlines into the country otherwise we will find ourselves back in the position of breeding related individuals. This is the reason why we wish to import an animal from Abilene Zoo and another from Pueblo Zoo from the US. The EEP stud book keeper, Ruben Holland has pre-selected the above mentioned animals specifically for our collection and has determined that they will be a good bloodline to mix with our current group of animals.

Since restarting the genetic viability of this species, ZAA have included this species into a Monitored Program and we have been approved to have our Senior Animal Keeper (Rebecca Surian) to act as Species Co-ordinator and Stud Book Keeper for Australasia – which means they have confidence in our capabilities and that we are committed to the conservation of this species. Please see confirmation of this position in Attachment A.

The animals are currently on Exhibit and our visitors are educated on their plight and what make this species so unique and special. A copy of the Fact Sheet (Attachment B) we have available for our visitors on our carts is included for your perusal but our presentations are conducted via a personalised talk from our Tour Guides that are there to answer any questions that visitors can come up with. It has been noted that more interest is gauged from visitors if they are able to ask what they want to know rather than read information off sheets or boards.

b) We have many employees at the Park and saw a need to reward competencies with certain species as they learnt and were able to manage each different species. Although the majority of our employees were competent before the date shown on the certificate we had not yet implemented the certificate distributions thus why many of the certificates have the same date.

We have 8 Certified Employees that are more than competent in handling Maned Wolves but as you can understand my Husband and I also manage these animals but did not see the need to award ourselves with a Certificate. Please find the Competency Certificates in Attachment C – 8 Pages. The competencies achieved involve: Essential Management, Care, Hygiene, Handling, Safety and Security Protocols.

- c) Besides the agreement with the US Zoos which is the reason why we are asking for the import I have included the document stating that Melbourne Zoo in Australia will be carrying out the required Quarantine time at their facility. Please find this agreement in Attachment D.

The Role of a Zoo or Wildlife Park should be not only for exhibition and education purposes but also to assist in the viability and credibility of an animal species. Many natural animal habitats are being destroyed for many varied reasons and if Zoos/Parks can keep species alive within their own establishments then the species have a higher chance of survival and hopefully being reintroduced into the wild at a later stage when Governments designate Wildlife Reserves where habitat destruction is minimised and poaching outlawed. This is specifically what Altina is about and our actual Mission States the following: Our mission is to create and maintain memorable educational visitor experiences and in so doing inspire unity in our mission to conserve wildlife and the environment.

- c) We have been caring and breeding Maned Wolves since November 2008 and since then have acquired many other Species. I have included copies of our Certification as a Registered Animal Establishment and also the Permit granted by DPI in NSW to exhibit certain prescribed species which include the Maned Wolves. (Attachment G 3 Pages).

d) In the last 5 years we have bred 18 individuals as follows:

2014 = 4.2.0

2013 = 5.1.0

2012 = 2.2,0

2011 = 0.2.0

2010 = Waiting on imports.

e) In the last 5 years we have had individual die as follows:

2014 = 1.0.0 (Euthanised due to Digestive Complications.

2013 = 0.2.0 (Euthanised due to Age Degeneration/Abnormal Growth in Intestines.

2012 = 0.1.0 (Ruptured Tumour – Aged animal)

2011 = 0.0.0 (No mortalities in this period.)

2010 = 1.0.0 (Snake Bite)





Maned Wolf

Scientific Name: Chrysocyon brachyurus

Habitat: Maned Wolves are naturally found in central and eastern South America, including northern Argentina, south and central Brazil, eastern Bolivia, Paraguay, and south eastern Peru. A variety of open habitats are utilized, including savannah, grassland, scrubland, swamps, marshes, and agricultural land.

Description: The fur blends from reddish brown to golden orange on the sides, with long, black legs and a distinctive black mane. The coat is further marked with a whitish tuft at the tip of the tail and a white "bib" beneath the throat. The mane is creetile, and is typically used to enlarge the wolf's profile when threatened or when displaying aggression. Adults stand almost limitall at the shoulder, and weigh 20 to 25 kg

Status: Vulnerable

Interesting facts:

- Diet: Maned wolves are omnivorous (eating both plants and animals such as rodents and birds)
- Group Structure: Maned wolves live in pairs (having one partner for life) and only interact during the breeding season.
- Reproduction: 62 66 days pregnancy after which a litter of 2 -5 pups are born.
- In captivity, males help raise pups by regurgitating food.
- Lifespan: 12-15 years
- Maned wolves are nocturnal (most active in the night) preferring to rest under forest cover during the day and hunt until sunrise.
- Maned wolves are very shy and only attack humans when they feel threatened or afraid.
- Maned wolves rotate their large ears to listen for prey animals in the grass. They tap the ground with a front foot to flush out the prey and pounce to catch it.






Image of Front Enclosure - Newly Constructed.






Night Den Areas.

- 3. The premises of origin has remained free from any evidence of rabies during the 12 months prior to certification.
- 4. No case or other evidence of Aleutian disease, Aujeszky's disease, babesiosis, brucellosis, pseudo tuberculosis, transmissible spongiform encephalopathy, trichinosis, trypanosomiasis, tuberculosis or tularaemia has been diagnosed at the premises of origin during the 12 months prior to certification in any animal of the same phylogenetic Family as the export animal(s).
- 5. Each animal has been individually identified with an International Standards Organisation (ISO) compliant microchip (transponder), and the site of implantation and the identification number of each animal is recorded on the veterinary certificate.
- 6. Each animal for export has been continuously resident in the premises of origin since birth or for 12 months prior to certification.
- 7. The animals for export were isolated from other animals not of the same health and residency status for 30 days prior to the scheduled date of export, and remained free from clinical signs of infectious or contagious disease until certification.
- 8. Each animal for export was treated for internal and external parasites with broad-spectrum parasiticides during the 30 days prior to export and the dates of treatment, active ingredients and dose rates used for each animal are recorded on the veterinary certificate.
- 9. Each animal has been inspected by an Official Veterinarian within 72 hours prior to export and found to be healthy and fit to travel.
- 10. Each animal is being shipped in a container that meets the container requirements specified in the International Air Transport Association (IATA) Live Animals Regulations.
- 11. After due enquiry the Official Veterinarian is satisfied that the container for the transport was new or was cleaned and disinfected prior to loading the animal(s). Containers constructed of timber were treated against insect infestation or fumigated prior to loading, as required by the Department of Agriculture.
- 12. After due enquiry the Official Veterinarian is satisfied that during transport, the animals will have no contact with other animals not of the same export consignment.

Transport

- 1. Exporters or their agents must have detailed plans to cover procedures including contingency plans, for transporting the animal from pre-export establishment until arrival in Australia.
- 2. Animals must be consigned to Australia by a route approved by the Department of Agriculture.
- 3. Animals must travel in a container recommended for that particular species under the International Air Transport Association (IATA) Live Animal Regulations.

5. The use of hay or straw as bedding during transport is not permitted. Treated wood shavings, sterilised peat and soft board can be used.

6. Animals must remain isolated from all animals except those that meet all the conditions described in this import permit, during transport from pre-export establishment until arrival in Australia.

Arrival in Australia

- 1. Importers or their agents must have a plan developed in consultation with the department to cover post-arrival procedures. The plan must include roles and responsibilities for their staff, vehicles for transporting animals to the quarantine approved premises (QAP) and road transport arrangements including contingency plans for vehicle and equipment failures.
- 2. Vehicles for transporting the animals from the port of entry to the QAP must be cleaned and disinfected to the satisfaction of the departmental officer before loading the animals. The department must be advised of the transport route to the QAP.
- 3. After the animals arrive at an Australian airport they must be transferred in their transport containers onto vehicles, along with personnel and equipment, and proceed directly to the OAP.
- 4. All personnel travelling with, or that have had contact with the animals, quarantine risk material or travel containers, must undertake appropriate decontamination measures as specified by the department before leaving the airport or the QAP if they are accompanying the animal to the QAP.
- 5. All quarantine risk material (e.g. bedding, feed, water and waste material) remaining at the airport must be sealed in bags, ordered into quarantine and disposed of under supervision of the department.
- 6. All equipment used during transport of the animal, and all baggage and personal equipment accompanying personnel, must be cleaned and disinfected under supervision of the department before leaving the airport.

Post-arrival quarantine

In this section, quarantine means the holding of animal in a place and under conditions specified by the department pursuant to the Quarantine Act 1908.

- 1. The post-arrival quarantine (PAQ) facility must meet the department requirements for a QAP class 7.9 facility.
- 2. The QAP must be approved by the department before entry of any animal into the QAP.
- 3. The QAP should be located within a secure part of a zoo or wildlife park approved under relevant Australian State or Territory legislation to hold the species being imported, separated from public access areas and where it is under regular supervision by a registered veterinarian.
- 4. The animal must be held in PAQ for at least 30 days. During this time the animal was isolated from other animals except those that meet all the conditions described in this import permit.
- 5. All PAQ operations and procedures must follow those outlined for a QAP class 7.9 facility and

- · A registered veterinarian must inspect the QAP before entry of any animal to ensure it has been cleaned and disinfectant applied to his/her satisfaction.
- The PAQ period will commence from the time of entry into the facility of the last animal.
- · Vehicles for transporting animals must not leave the QAP until thoroughly cleaned and disinfected.
- · If any animal dies during PAQ, the department must be notified within 24 hours and the animal must undergo a post mortem examination by a registered veterinarian to determine the cause of death.
- The department is to be advised within 24 hours of any disease incident and its outcome.
- Animals must not leave the QAP during PAQ without permission of the department.
- At the satisfactory completion of PAQ, the animal will be released from quarantine into premises approved by the appropriate State or Territory governments for the holding of zoo carnivores.
- 6. Animals imported under these conditions will be held under quarantine surveillance until two years after importation. After this time, if they are free from suspicion of a quarantinable disease, they will be released unconditionally from quarantine. Conditions of quarantine surveillance include: notification by the owner to the department of any signs of sickness, death or intended transfer of the imported animal to another facility.

Both Pueblo Zoo and myself submitted our applicants at the same time, since the wolves are supposed to ship together. They received their approved export permit a few weeks ago and unfortunately we haven't. Australia needs us to ship on Monday, October 5th in order for both wolves to enter quarantine on the 7th in Australia. If not, then shipping will be pushed back and we miss the breeding season.
