Why the Size Standard Needs to be Significantly Increased

Introduction

The U.S. Small Business Administration's (SBA) industry-specific size standards define whether a business entity is small and, thus, eligible to participate in federal government business development and contracting set-aside programs. Due to an ever-shifting economy and other market factors, it is the duty of the SBA to continually review and revise these industry size standards on regular intervals, to satisfy congressional intent to ensure the maximum participation of small businesses in the federal contracting field.

In this report, we analyze the unique case of the Engineering Services industry, which corresponds with North American Industry Classification System (NAICS) code 541330.

Herein, we examine complications that result from the Brooks Act¹, outline challenges facing firms that have graduated above the current \$16.5M size standard, and discuss why it is crucial to increase the Engineering Services industry's size standard from \$16.5M to \$39.5M.

Background on Small Business Size Standards

Arguably the most complicated and impactful question in Federal Government contracting sounds like a simple one: "What is a small business?"

SBA's size standards define whether a business entity is small, and therefore eligible for Government programs and preferences reserved for "small business" concerns. While people often think of a business as being "small" if it has fewer than 500 employees, which was used as the threshold in the recent CARES Act, the actual way to determine a company's size is much more complex. Size standards have been established for hundreds of different industries, based on the firm's North American Industry Classification System (NAICS) code.

NAICS assigns codes to all economic activity within twenty broad sectors and over 1,000 different industries. A detailed table matching a size standard with each NAICS Industry or U.S. Industry code is published annually by the SBA in the Federal Register. Typically, size standards for

manufacturing firms are based on employee counts and the size standards for services firms are based on revenue; namely the average annual revenue of the trailing 5 years.

SBA considers economic characteristics comprising the structure of an industry, including degree of competition, average firm size, start-up costs and entry barriers, and distribution of firms by size within that sector or industry. It also considers technological changes, competition from other industries, growth trends, historical activity within an industry, unique factors occurring in the industry which may distinguish small firms from other firms, and the objectives of its programs and the impact on those programs of different size standard levels.

As part of its review of a size standard, SBA investigates if any concern at or below a particular standard would be dominant in the industry. SBA takes into consideration market share of a concern and other appropriate factors which may allow a concern to exercise a major controlling influence on a national basis in which a number of business concerns are engaged. Size standards seek to ensure that a concern that meets a specific size standard is not dominant in its field of operation.

As part of its periodic reviews, SBA's Office of Size Standards examines the impact of inflation on monetary-based size standards (e.g., receipts, net income, assets) at least once every five years and submit a report to the Administrator or designee. If SBA finds that inflation has significantly eroded the value of the monetary-based size standards, it will issue a proposed rule to increase size standards.

NAICS 541330 (Engineering Services): A Unique Case

For any federal contracting solicitation requiring Architect/Engineer (A&E) services, the acquisition must follow the rules laid out in the Brooks Act. This law, which was enacted on October 18, 1972, articulates the rules for Qualifications Based Selection (QBS). QBS establishes the procurement process by which architects and engineers (A/Es) are selected for design contracts with federal design and construction agencies.

The Brooks Act establishes a qualifications-based selection process, in which contracts for A/Es are negotiated on the basis of demonstrated competence and qualification for the type of professional services required at a fair and reasonable price. Under QBS procurement procedures, price quotations are not a consideration in the selection process.

There are seven basic steps involved in pursuing federal design work under QBS:

1. Public solicitation for architectural and engineering services
2. Submission of an annual statement of qualifications and supplemental statements of ability to design specific projects for which public announcements were made

3. Evaluation of both the annual and project-specific statements
4. Development of a short-list of at least three submitting firms in order to conduct interview with them
5. Interviews with the firms
6. Ranking of at least three of the most qualified firms
7. Negotiation with the top ranked firm.

In order to be competitive in an environment where the Brooks Act is predominantly used in the acquisition process, an A&E firm must be able to demonstrate its capabilities and qualifications in absence of pricing data. This means that competition is solely based on capabilities, and those capabilities can be directly tied to the number of professionals and past projects that the firm has successfully completed.

Why is this an important public policy issue?

NAICS Code 541330 is the second largest spend category for the entire Federal government²

It is second only to Aircraft Manufacturing in terms of annual Agency spend. Setting an appropriate size standard is critical for such a dominant NAICS code. Increasing the ability for businesses to participate in small business set-aside opportunities, will have a positive impact on competition and will further job growth and economic sustainability. In addition, it will spur savings for buying Agencies through increased competition and will foster and support a thriving industrial base.

One key issue is that the current size standard doesn't allow for firms to reach the size and scale necessary to effectively compete for contract awards in the full and open market place. The industry is therefore far too concentrated at the top, and the data proves this³. Underscoring the size disparity between firms at the top end of this industry and the small business size standard, even the 20th largest player in this market has government contract revenues that are 15x the size standard threshold (not even including any of their commercial business)⁴.

For proof that this is stifling competition, and all the associated benefits to Agencies and the taxpayer, **the government averages fewer than 3 bidders per contract in this NAICS**, so clearly engendering more competition will be a positive⁵.

At DOD, which is the largest spender in this industry, 47% of contract dollars in NAICS 541330 go to the Top 10 vendors. It is significantly worse at NASA and DOT, where the **Top 10 vendors receive 70%+ of contract dollars!**⁶

Part of the reason this anti-competitive concentration is occurring is due to how agencies procure these services. **Over 70% of the dollars go out through Indefinite Delivery Contracts**⁷ – meaning that the pool of potential dollars for businesses in the \$17-50m revenue range is incredibly small.

In this environment a firm cannot be competitive in the full and open marketplace unless it has a cadre of professionals with in-depth experience in all facets of the industry. A typical firm looking to successfully vie for Federal contracts in the full and open marketplace needs to have roughly **200-500 professionals on staff to be competitive**. For reference, a firm that is within the current revenue-based size standard of \$16.5M, would typically only have between 100-125 professionals on staff, and that is if they are near the upper bounds of the size standard. Firms which have the necessary professional resources to be competitive in the full and open market place are typically generating annual revenues of \$35+M.

A firm graduating from the size standard, at just above \$16.5M in revenue cannot be competitive in the full and open marketplace.

Therefore, firms have a perverse incentive to not grow, as growth would in effect be a death knell by causing them to lose “small” business status. If the firm is successful enough to earn its way above the revenue threshold, there is typically only two options:

- 1) Consider a Mentor-Protégé Joint Venture with a large firm, or
- 2) Actively seek to be acquired by another firm.

In order to be competitive upon graduation from the size standard, a firm should have at least 200-1,000 professionals on staff. Using the average revenue per employee for A/E firms, this equates to \$30M - \$151M in annual revenues.⁸

Another consideration is that a significant portion of the revenues received by A&E firms, which count towards their size standard threshold, is subcontracted out in order to meet the specialized experience requirements. Therefore, although they book a significant amount, much of it is a pass

through to subcontractors. A&E contracts can be large, and therefore the prime books a significant revenue, but much of it is subcontracted.

Conclusion

There are several unique aspects of the Engineering Services industry which merit a substantial increase in its size standard. All procurements in this industry are subject to the Brooks Act, which directly ties capabilities to the number of professionals and past projects while excluding the consideration of price. This industry also represents the Government's second largest spend by dollars, with a high concentration of federal dollars awarded to the top ten firms. Furthermore, there is limited competition on each solicitation within this industry. The most commonly used contract vehicles significantly limit the ability of small businesses to even access many contracting opportunities, let alone submit competitive bids. Therefore, in order to secure our nation's industrial base and maximize the flow of public contracting dollars to small businesses, it is crucial to update the size metrics accordingly, so that firms who are graduating from the size standard can reasonably have a chance of competing in the full and open federal contracting marketplace. **Therefore, we, the undersigned and co-signatories⁹, are requesting SBA to increase the revenue-based size standard for NAICS 541330 to no less than \$39.5 Million, comparable to the Commercial and Institutional Building Construction industry.** Such an increase will allow architectural and engineering firms to successfully, and reasonably participate in the federal marketplace.




